



# **YOUTH (UNDER 18) WAIVER OF LIABILITY, RELEASE, & ASSUMPTION OF RISK**

**Parent or legal guardian of the volunteer youth must sign this waiver!**

Fort Worth Area Habitat for Humanity, Inc. DBA Trinity Habitat for Humanity (Habitat) encourages minors to help on Habitat construction sites. Their activities, however, are limited to what is deemed safe for minors by the Texas Workforce Commission Child Labor Laws, Habitat for Humanity International, and Habitat's insurance carrier.

**I, individually and as parent or guardian of the minor listed below (hereinafter the "Minor"), understand that building construction involves certain risk and dangers of accidents, serious personal and bodily injury, including death and permanent disability, and property loss and damage. I, individually and as parent or guardian of the Minor, voluntarily and freely choose to accept and assume such risks and dangers, both known and unknown and even if arising from the negligence of others, in relation to volunteering for Habitat for Humanity and on my behalf and on behalf of the minor listed below. I understand that, as volunteers, we are not covered by Workers Compensation Insurance. I accept full responsibility for my own safety and the safety of the minor listed below.**

**I, individually and as parent or guardian of the minor listed below, understand that Fort Worth Area Habitat for Humanity, Inc. DBA Trinity Habitat for Humanity (Habitat), the Group The Minor Is Volunteering With Today, the House Project's sponsor organization(s) or volunteer organization(s), and each of their employees, agents, and representatives, and any and all other volunteers on the House Project (collectively the "Releasees") will not be liable for any injuries or illness that I, the Minor, or any of our dependent(s) may suffer which arise directly or indirectly in connection with this House Project, regardless of the negligence or fault of Releasees.**

**I, individually and as parent or guardian of the minor listed below (the "Minor"), hereby expressly WAIVE and RELEASE any and all claims for compensation or liability arising out of an injury, illness, or death that I, my dependent(s), or the dependent(s) of the Minor may sustain, directly or indirectly in connection with the House Project, and hereby RELEASE AND AGREE TO HOLD HARMLESS Habitat and the Releasees of and from any claim or cause of action for personal injury, illness, medical expense, or death arising directly or indirectly from, or caused by any act or omission, in connection with the Minor's volunteering for Habitat and the House Project that I, my dependent(s), or the dependents of the Minor may sustain, regardless of whether caused in whole or in part by the negligence or fault of any Releasee.**

**This waiver and release of liability also extends to any claim arising out of first aid, treatment, and medical services rendered and extends to all periods of construction of this House Project or any other volunteer work that myself or the Minor on behalf of Habitat.**

I do hereby grant all right, title, and interest I may have in any and all photographic images, and video/audio recordings, created by Habitat or its agents or employees during the Minor's work for Habitat including, but not limited to, any royalties, proceeds, or other benefits derived therefrom.
